

**SUMMIT BROADBAND SUMMER GIVEAWAY
OFFICIAL RULES**

1. **ELIGIBILITY: The Summit Broadband Summer Giveaway** (the "Giveaway" or "Promotion") is open only to legal residents of the State of Florida who reside within the Summit Broadband service area (the "Serviceable Area") and are 18 years of age or older. Employees of **Summit Broadband Inc.** (the "Sponsor"), its parent (as applicable), affiliates, subsidiaries, advertising, promotion partners and internet agencies, and any other companies engaged in the development, administration, production, fulfillment or distribution of materials for this Promotion, and each of their respective officers, directors and agents (collectively "Released Parties") and their immediate family members (spouse, parent, sibling, grandparent and children, regardless of where they live) and/or those living in the same household of each are not eligible. 3. **3. HOW TO ENTER:** Simply attend Leesburg 4th of July Spectacular Event, between 4PM and 9PM Eastern Time, and scan the QR Code located at the main table of Summit Broadband tent. Once you scan the QR Code, complete the 4th of July raffle form.

Limit one entry per person/household using only one (1) email address throughout the Promotion Period, regardless of method of entry. Entries received in excess of the limits stated herein will be void. Any entry information collected for/from the Promotion shall be used only in a manner consistent with these Official Rules.

4. **RANDOM DRAWING:** A random drawing to select winners will be conducted between July 7th, 2025 and July 11th, 2025 from among all eligible entries received. The random drawing will be conducted by the Sponsor, whose decisions are final. Odds of winning will depend on the number of eligible entries received.
5. **WINNER NOTIFICATION AND VERIFICATION:** Prize award is subject to eligibility verification. Potential winners will be notified by phone by the Sponsor and may be required to execute and return a Declaration of Compliance, and where lawful, a Publicity Release. Winners of prizes valued at \$600 or more will be required to return a completed W9 tax form which will be used solely for tax reporting purposes (collectively "Documents"). Completed Documents must be returned within 5 days (including Saturdays, Sundays and Holidays) of attempted delivery of same. Failure to return properly completed Documents within the specified time or return of any prize/prize notification as undeliverable, will result in disqualification without further notice and an alternate winner will be selected. If a potential winner is deemed ineligible, fails to comply with the Official Rules or is unable to claim the prize as specified, the potential winner will be disqualified, and Sponsor will attempt to award the applicable prize to an alternate winner via a random drawing from among all remaining eligible entries.
